Directions for Use:

Initial Administration (4 to 6 week period)

Weight	Amount
Under 30 lbs	½ to 1 chew daily
31 – 60 lbs	1 to 2 chews daily
61 – 120 lbs	2 to 3 chews daily
Over 120 lbs	4 to 5 chews daily

Maintenance Administration*

Weight	Amount
Under 30 lbs	½ chew every other day
31 – 60 lbs	½ chew daily
61 – 120 lbs	1 chew daily
Over 120 lbs	2 chews daily

*May be doubled for moderate cases

Storage: Store at controlled room temperature of 20 - 25° C (68 - 77° F).
